**RENTAL CONDITIONS AND TERMS**

Please read, sign and date the following RENTAL agreement/disclaimer. This agreement must accompany payment. We will NOT leave our facility without it!

- All Pro Sports Rings and Fight Cages LLC “Rental Rates includes the delivery of a Pro Wrestling Ring to and from your event location. We provide installation and disassembly assistance for YOUR workers.
- Hotel accommodations and fuel surcharges apply. Contact us for current rates.
- Additional “Rental Days” are billed at \$500.00 per day plus accommodations.
- Set-up access must be provided a minimum of 4 hours prior to start of event.
- Normal setup conditions include morning set-ups for evening events. Evening or Day Before set-up requirements available per client and event needs.
- Disassembly must take place within 2 hours after event is complete.
- Renter MUST provide a minimum of 4 laborers to assist with moving and setting up wrestling ring equipment from the trailer to the actual set-up point. If the trailer cannot be backed to within 20 feet of the actual set-up point, or there is a RUSH on your part for set-up, an additional 4-6 laborers will be required for the set-up and tear-down process.
- If renter CANNOT provide the additional laborers a \$500.00-\$1,000.00 charge will apply, depending on distance to drop point. Elevators, long hallways, stairs, etc. will result in additional fees. (Please measure and know your event location)
- If the Renter is scheduling more than 30 days prior to event, a 50% deposit of the total rental fee amount plus 50% of the fuel surcharge is required to secure rental date. The remaining 50% balance of the rental fee and fuel surcharges is due NO LATER THAN 14 days before we leave our facility.
- If the Renter is scheduling less than 30 days prior to event, the full rental fee plus the full fuel surcharge is required at time of scheduling to secure rental date.
- If the Renter’s event gets cancelled for any reason whatsoever after we leave our facility, or less than 7 days before event, all monies paid will be forfeited.
